District Educational Funds Emphasis for 2014—\$9,294 Goal

The mission emphasis for 2014 MonValley District Charge Conferences will be the three Educational Funds established by General Conference. **MEF (Ministerial Educational Fund)** provides scholarships for Licensing School, Course of Study, and Seminary as well as continuing formation events in our Annual Conference. (25% of monies received are returned to our Annual Conference.) Your pastor has benefited from MEF funds in some way. The **Africa University Fund**, provides scholarships to the only degree granting institution of higher education supported by the UMC in Africa. Young men and women from 25 countries come to complete undergraduate and graduate degrees. The **Black College Fund** supports the 11 historically Black United Methodist colleges and universities here in the United States. As is our custom, Superintendent Rick DeQuasie will be asking for a check from each church for \$1 per member at Charge Conference made out to "MonValley District" to insure that we reach our district goal of \$9,294. (**Do not send this money or district apportionments through the Conference Treasurer's office with your conference apportionment.**) Because of your faithfulness, our Annual Conference has been able to pay 100% of these funds over the past 5 years. "Thank you" to those churches that will be faithful to this mission asking.



2014 West Virginia Annual Conference Summary

The 46th session of the West Virginia Annual Conference met June 12-15 at West Virginia Wesleyan College in Buckhannon, W.Va. Bishop Sandra Steiner Ball presided during the session which emphasized the theme, "Discover Christ."

Guest preacher, Bishop Thomas J. Bickerton (Western PA area) returned to the place of his ordination to preach at two worship services. His first sermon, "Discover Relationship," was based on the conversation Jesus had with the Samaritan woman at the well, as told in the Gospel of John.

"I believe this story represents one of the greatest challenges of the Christian journey, to love people like he (Jesus) did," said the bishop.

Bickerton preached again Friday morning, where he urged the conference to re-discover joy. He used the song "Happy" by Pharrell Williams to demonstrate joy and conference members responded by dancing in the aisles of Wesley Chapel.

The conference also concluded a year of emphasis on Imagine No Malaria. Since 2007, the conference has raised \$425,000 to combat the deadly disease.

The Cabinet of the West Virginia Annual Conference presented a report that demonstrated the perseverance and hope local churches and ministries show even in times of hardship and "giants in the land" such as addiction, depression and the perceived cultural irrelevance.

Resident and presiding Bishop, Sandra Steiner Ball based her address on Isaiah 40, verse 31: "but those who hope in the LORD will renew their strength. They will soar on wings like eagles; they will run and not grow weary, they will walk and not be faint."

"God wants to renew our strength, to make us able," she said. "I hear Isaiah telling us to look around at the big world. Behind it is a creator who has the expansive power of life that can make a grasshopper soar like an eagle."

Dr. Elaine Heath led two conference teaching sessions that focused on how missional communities can reach new people.

Bishop Ernest S. Lyght, who served the West Virginia Conference from 2004 - 2011 preached a sermon during Sunday morning ordination that encouraged attendees to embrace the steps along the journey of faith.

"When we are on the spiritual path, the whole world is open," he said. Conference passed a resolution that strengthens clergy training regarding the issue of sexual assault. They also approved a rule change that allows seminarians to take up to 66 \(^2\)3\% of their courses online, except for those related to preaching and pastoral care.

Conference adopted a \$12,027,139 budget for 2015, a decrease of \$59,829 or 0.49% less than the 2014 budget.

At the end of 2013, membership stood at 97,363, down 1,818 from the end of 2012. Worship attendance stands at 41,820 down 1,725. Church school attendance stands at 19,455, down 1,372.

Seven elders and three deacons were ordained. Five were commissioned: one as a deacon and four as elders. Nine elders, one deacon, and four associate members entered into a retired relationship with the conference. Eight local pastors were recognized as retired.

Minimum Financial Standards and Internal Controls for Local Churches

- the following guidelines shall be in place for all local churches as a measure of protection for those with financial responsibilities in the church. These <u>minimum</u> standards should be increased for churches with higher volumes of transactions but must not be compromised for lower volumes of transactions. **All local churches shall meet these minimum standards and internal controls**.

- 1. Treasurer and Financial Secretary shall not be the same person and shall not be in the same immediate family residing in the same household.
- 2. Counting teams (of at least two unrelated persons) should count offerings and document totals. The treasurer and financial secretary shall not be members of the counting teams.
- 3. Offerings should be deposited the same or next business day.
- 4. Offering count details should be given to financial secretary for recording.
- 5. Offering totals should be given to the treasurer to record deposit.
- 6. The Financial Secretary's deposit records should be compared to the bank statement to verify deposits (by bank reconciliation reviewer).
- 7. At least two persons should be listed as authorized signatures on all accounts.
- 8. Financial policy and authority guidelines should be written and approved by the Finance Committee.
- 9. Invoices or some documentation shall be required for all payments from all accounts.
- 10. Someone other than the treasurer (with authority by Finance Committee) should approve invoices for payment.
- 11. The Treasurer should make payments only after the invoice is approved.
- 12. All accounts should be reconciled monthly.
- 13. Someone other than treasurer should review bank reconciliations at least bi-annually including bank statements, invoices, checks written, and financial reports.
- 14. The Treasurer should make detailed report of budget and designated fund activities to the Finance Committee at least quarterly.
- 15. There must be a full annual audit of ALL accounts done (at least in as much detail as the Local Church Audit Guide) every year for all churches. 2012 Book of Discipline 258.4(d).
- 16. W-2s must be issued for employees and 1099s issued for nonemployee compensation by January 31 for preceding year (federal law requirement).
- 17. Payroll tax forms and deposits done as required for payroll amount (federal law requirement) payroll reporting should be completed for the IRS and SSA by appropriate due date for riling method.
- 18. Housing allowance or exclusions that are approved annually at charge conference should be kept on file (federal law requirement).
- 19. Prepare a list of all church property for insurance purposes include item description, serial number and value.
- 20. Prepare list of safety deposit box contents update authority as needed access should be allowed by two unrelated people.
- 21. Computer records should be backed up and password protected for security.
